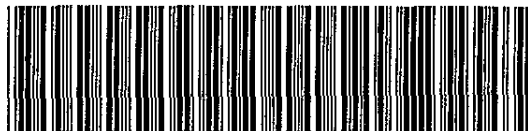

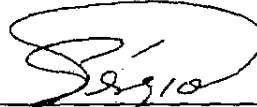
### **ARTICLE XI – EFFECTIVE DATE**

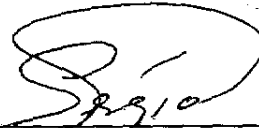
