ARTICLES OF INCORPORATION **OF** BBIS, INC. (A FLORIDA CORPORATION)

OS NO THE STATE OF ST The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida, as follows:

ARTICLE ONE: The name of the Corporation shall be:

BBIS, Inc.

ARTICLE TWO: The corporate existence of the corporation shall commence upon the filing of these articles by the Department of State, and the period of duration of the corporation is perpetual.
