**ARTICLES OF INCORPORATION  
for

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the Corporation is Malat Vending Co. Principal place of business is 9300 Sunrise Lakes Blvd, Sunrise, FL 33322, Suite 210.

**ARTICLE II: DURATION**

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.
