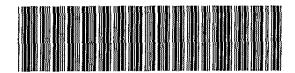

The undersigned adopts these Articles of Incorporation for purposes of forming a corporation under the Florida Business Corporation Act:

#### ARTICLE ONE NAME OF CORPORATION

The name of this corporation is: MAINLINE CONSTRUCTORS, INC.
