

**The undersigned, for the purposes of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, does hereby certify as follows:**

**ARTICLE I**

**Corporate Name and Address**

**The name of the Corporation is KIH, Inc., and the mailing address of the Corporation is Post Office Box 62021, Fort Myers, Florida 33906.**

**ARTICLE II**

**Corporate Purpose**

**The Corporation is organized to transact any and all lawful business authorized by the Florida Business Corporation Act.**

**ARTICLE III**

**Authorized Stock**

**The aggregate number of shares of the Corporation shall be 1,000, all of which are to be voting common stock having a par value of \$1.00 per share.**

**ARTICLE IV**

**Registered Office and Registered Agent**

**The street address of the initial registered office of the Corporation in the State of Florida shall be 2111 SE 8<sup>th</sup> Place, Cape Coral, Florida 33990. The name of the initial registered agent of the Corporation at the registered office shall be Karam Henoud.**

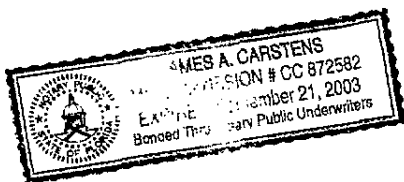




