## ARTICLES OF INCORPORATION

REMOTE CONTROL CURATORIAL, INGLLAHASSEE, FLORIDA

#### ARTICLE I. NAME

NAME: The name of this corporation is REMOTE CONTROL CURATORIAL, INC.

#### ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the \_\_\_\_\_\_ day of <u>August</u>, 2003.
