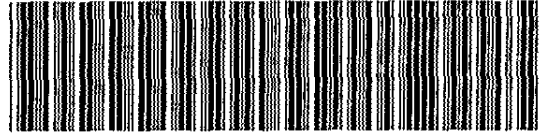

ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.:

Article 1-Name

The name of the corporation is D.D.C.Trading Group Inc.

Article 2-Nature of Business

The corporation is organized to engage in any activity or business permitted under the laws of the United States and the state of Florida.

Article 3-Capital Stock

Article 10-Amendments






