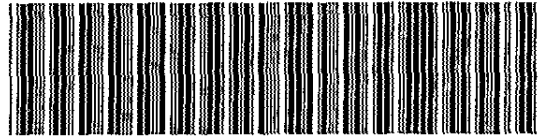

The existence of this Corporation shall be perpetual.

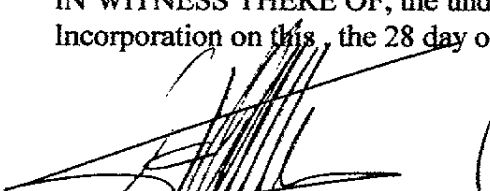
