Per our conversation this morning, the following are the events that occurred with the filing of the Corporate Annual Report for Fertile Ground Company.

I mailed the original report along with the \$150.00 filing fee April 23, 2004. (I might add, I mailed 5 other reports at the same time and had no problem with those reports.)

May 12, 2004 I received a notice of dissolution of the corporation. My assistant, Michele Smith contacted Melinda Lillistrom and was requested to mail a copy of the report along with the FEI number and Ms. Lillistrom would take care of the problem. Ms. Smith did in fact forward this information via the United States Postal Service at Post Office Box 6327, Tallahassee, FL 32314.

I received another notice of dissolution October 22, 2004 and I called you. That very day, I copied my file and forwarded it to your attention. During that conversation, you assured me you would take care of the problem.
