ARTICLES OF INCORPORATION

The undersigned incorporator, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of the corporation is XTREME LIMOUSINES CORPORATION

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the corporation's principal office and the corporation's mailing address are 3571 N.W. 85th Way, Apt. 102, Building 10, Sunrise, Florida 33351.

ARTICLE III

DURATION AND COMMENCEMENT OF CORPORATE EXISTENCE

The corporation shall exist perpetually. The corporate existence shall commence upon the filing of these Articles of Incorporation with the Department of State.

ARTICLE IV

NATURE OF CORPORATE BUSINESS

The corporation, through its officers, employees, agents and consultants, shall be authorized to engage in every aspect and phase of limousine service in the State of Florida; to engage in any activities which will facilitate and promote its expertise in the limousine consulting through its officers, employees, agents and consultants; and to invest and reinvest its funds in any other type of

ARTICLE V

CAPITAL STOCK

The corporation is authorized to have outstanding one class of stock, to be designated as Common Stock. The maximum number of shares of Common Stock which the corporation is authorized to have outstanding is one thousand (1,000) shares of Common Stock of a par value of \$.01 per share. Holders of Common Stock are entitled to vote on all questions required by law on the basis of one vote per share and there shall be no cumulative voting. Holders of Common Stock shall have pre-emptive rights to subscribe to the corporation's securities and are entitled to receive the not assets of the corporation upon dissolution.
