We are enclosing our check #4920 in the amount of \$150.00 for the 2005 Annual Report fee to the above referenced document number for Oceano Graphics Corporation.

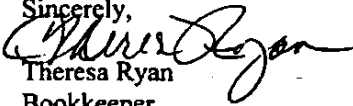
We downloaded the annual report from your website to correct the address listed under Officers & Directors. Please note, this annual report is requesting \$550.00 for an annual report fee.
