Per my telephone conversation with Yula in the office of Reinstatement and Annual Reports on Friday Aug. 6th, attached you will find our corrected Annual Report for 2004. Yula advised me that our previous filing had been rejected because the Annual Report, document #P030000085629, was not completed correctly. Therefore, attached you will find our CORRECTED 2004 Annual Report, indicating our FEI Number, 20-0133466, which was inadvertently left off the report we originally filed April 23, 2004, with our check #1073 (copy of processed check also attached).

This letter supercedes our correspondence sent to you August 3, 2004, which was based on information I received by phone from other representatives in your offices in which I was told the reason for rejection was because our completed form was not included with our check, and as a result our check along with a rejection letter had been mailed back to us May 5, 2004. We did not receive this rejection letter or any other correspondence from your offices (including our check). Until Friday, August 6th, we were not aware that the only item missing from the information we submitted was our FEI number in box #4 on the Corporate Return form. I did not have the correct information to properly complete and re-submit our Corporate Annual Report for 2004 to avoid Dissolution of our Corporation. Based on this information, and given our filing fee of \$150 was received and processed into your system on time (funds paid by our bank on May 5, 2004), we are requesting that the \$400 penalty for late filing be waived.
