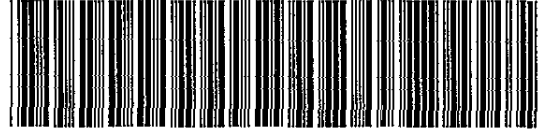

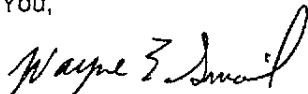

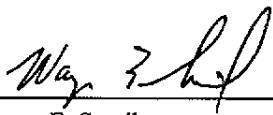
### ARTICLE VIII - BYLAWS
