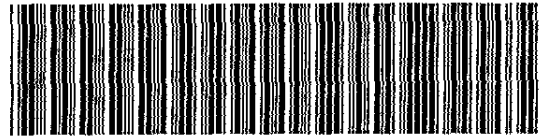



THE UNDERSIGNED, acting as sole incorporator of **STEPHEN P. GULDENSCHUH AND GREGORY V. BRONSON, INC.**, under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be **STEPHEN P. GULDENSCHUH AND GREGORY V. BRONSON, INC.**

ARTICLE II

Shares

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.

Initial Board of Directors


