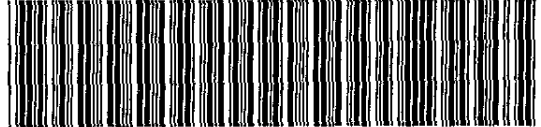

alter or abolish such reserve.

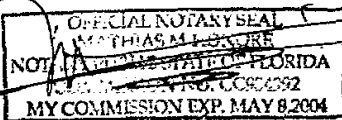

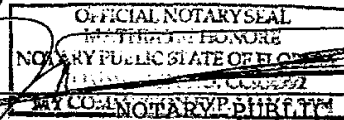
