

### ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF E-SAFE, INC.



TO: Department of State Tallahassee, Florida 32304

Pursuant to the provisions in Section 607.1006 of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation pursuant to a meeting of the shareholders of the Corporation duly called on August 10, 2004:

1. The following amendment to the Articles of Incorporation of E-Safe, Inc. was adopted by holders of a majority of the outstanding shares of the common stock of the corporation on August 10, 2004, in the manner prescribed by the Florida General Corporation Act

#### Article V
