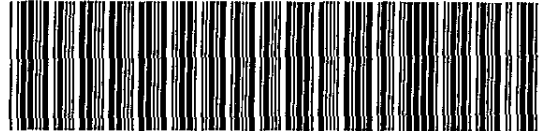

ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED INCORPORATOR, STEPHEN DEPIRRO, HEREBY FORMS STAR DENTAL LAB, INC., A CORPORATION UNDER CHAPTER 607 OF THE LAWS OF THE STATE OF FLORIDA.

ARTICLE I. NAME

THE NAME OF THE CORPORATION SHALL BE:
