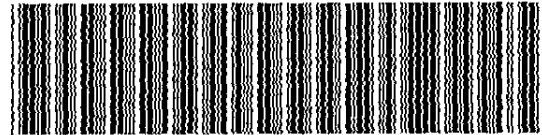

NAME**

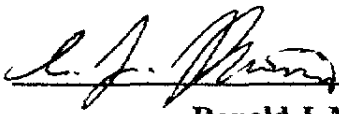
