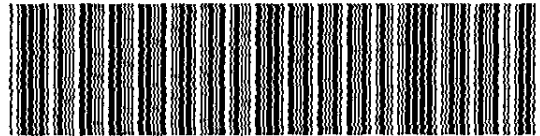

ARTICLES OF INCORPORATION
OF
NASC - BRADENTON, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: NASC - BRADENTON, INC. The principal place of business of this corporation shall be 1250 Rogers Street, Suite E, Clearwater, Florida 33756.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, county, territory or nation.
