

ARTICLES OF INCORPORATION

OF

NASC - ST. PETE SOUTH, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: NASC - ST. PETE SOUTH, INC. The principal place of business of this corporation shall be 1250 Rogers Street, Suite E, Clearwater, Florida 33756.
