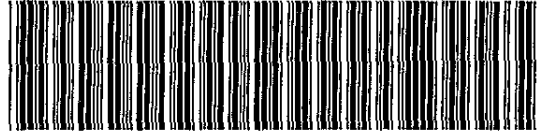

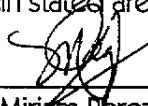
ARTICLE IX BY-LAWS
