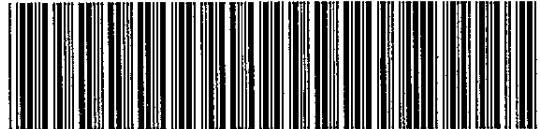

**ARTICLES OF INCORPORATION
OF

A Florida Corporation

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I- NAME

The name of this corporation is Nidia M. Iglesias, M.D., P.A.

ARTICLE II- MAILING ADDRESS AND PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be: 4302 Alton Road, Suite 560, Miami Beach, Florida 33140.

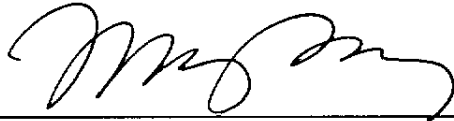
