

# ARTICLES OF INCORPORATION 4, PM 3: 57 OF

#### P & P FINANCE CORP.

THE UNDERSIGNED, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation:

#### **ARTICLE I**

The name of the corporation is:
