**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF**

MAINSTREET COMMUNITY BANK OF FLORIDA

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of Mainstreet Community Bank of Florida are hereby amended as follows:

FIRST: Article III of the Articles of Incorporation is hereby amended by deleting the text thereof in its entirety and substituting the following in lieu thereof:

The aggregate number of shares that the Corporation shall have the authority to issue is Five Million Three Hundred Thousand (5,300,000) common shares (the "Shares"), of which Five Million One Hundred Fifty Thousand (5,150,000) shares shall be designated as Class A Voting Common Shares and One Hundred Fifty Thousand (150,000) shares shall be designated as Class B Non-voting Common Shares. The Shares shall have a par value of \$5.00 per share. The Class A Voting Common Shares are entitled to all voting rights and powers. The Class B Non-Voting Common Shares are not entitled to any voting rights and powers except such as are required bylaw, and the holders thereof shall not be entitled to notice of any meeting of shareholders, except as required by law. In all other respects the Class A Voting Common Shares and the Class B Non-voting Common Shares shall be identical.

The Board of Directors by vote of a majority of the whole Board is expressly authorized to adopt such resolutions and issue stock from time to time as it may deem desirable.

The Corporation elects to have preemptive rights.

SECOND: The foregoing amendment was adopted by the holders of in excess of a majority of the outstanding shares of common stock, being the sole voting group entitled to vote on the amendment, as of April 15, 2011 and the number of votes cast for the amendment was sufficient for approval by the holders of common stock.

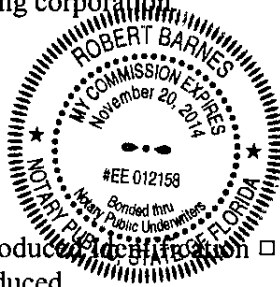
