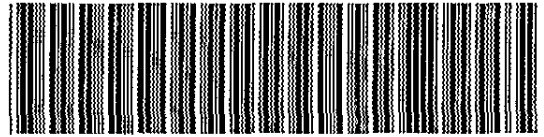

Mainstreet Community Bank of Florida, whose Articles of Incorporation were filed with the Florida Department of State on August 6, 2003, does hereby file the following Restated Articles of Incorporation pursuant to Sections 607.1007 of the Florida Business Corporation Act (the "Act"):

ARTICLE I

The name of the corporation shall be Mainstreet Community Bank of Florida and its initial place of business shall be at 302 South Woodland Blvd., DeLand, Florida 32720 in the County of Volusia and State of Florida.

ARTICLE II

The general nature of the business to be transacted by this corporation shall be that of a general commercial banking business with all the rights, powers, and privileges granted and conferred by the Florida Financial Institutions Codes, regulating the organization, powers, and management of banking corporations.

ARTICLE III

The total number of shares authorized to be issued by the corporation shall be 2,000,000. Such shares shall be of a single class and shall have a par value of \$5.00 per share. The corporation shall begin business with at least \$3,750,000 in paid-in common capital stock to be divided into 750,000 shares. The amount of surplus with which the corporation will begin business will be not less than \$3,250,000. The corporation elects to have preemptive rights.

ARTICLE IV

The term for which said corporation shall exist shall be perpetual unless terminated pursuant to the Florida Financial Institutions Codes.

ARTICLE V

The number of directors shall not be fewer than five (5). The names and street addresses of the first directors of the corporation are:
