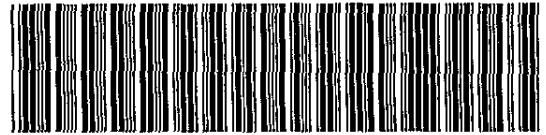

**ARTICLES OF INCORPORATION  
OF**

**LeWal Investments, Inc.**

The undersigned, acting as subscribers of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

**ARTICLE I**

The name of this corporation is, **LeWal Investments, Inc.**

**ARTICLE II**

The principal place of business of the corporation shall be located at 1701 S W 64<sup>th</sup> Terrace, Pompano Beach, FL 33068.

**ARTICLE III**

The purpose is to engage in any activities or business permitted under the laws of the United States and the State of Florida.



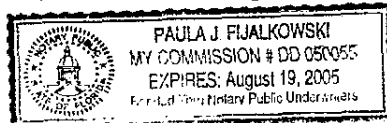
