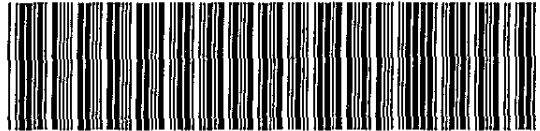

**ARTICLES OF INCORPORATION
OF**

**The undersigned, for the purpose of forming a corporation under the
Florida General Corporation Act, do hereby adopt the following Articles of
Corporation.**

ARTICLE I

**The name of the corporation shall be: WAYNE ROWLAND TRUCK
& AUTO BROKERS, INC. , principal office of this corporation shall be:
3793 Hwy. 441 S.E., Okeechobee, FL. 34974. The mailing address shall be
3793 Hwy. 441 S. E., Okeechobee, FL. 34974.**

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The general purposes for which the corporation is organized are:

**1. To such extent as a corporation organized under the Business
Corporation Law of the state may now or hereafter lawfully do. To do, either as
principal or agent and either alone or in connection with other corporations, firms,
or individuals all and everything necessary, suitable, convenient, or proper for, or in**

connection with, or incident to the accomplishment of any of the attainment of any more of the objects herein enumerated, or designed directly or indirectly to promote the interests of this corporation or to enhance the value of its properties: and in general to do any and all things and exercise any and all powers, rights, and privileges which a corporation may now or hereafter be organized to do or to exercise under the business corporation law of this state or under any act, amendatory thereof, supplemental thereto, or substituted therefore.

2. To do such things that are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 shares of common stock having \$1.00 par value per share.

ARTICLE V

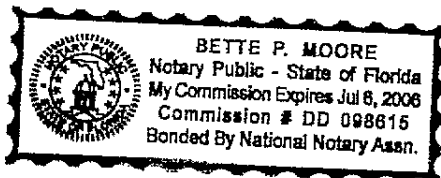
