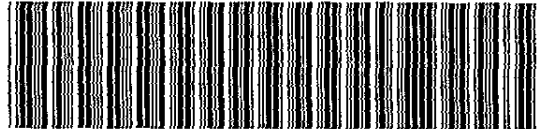



**ARTICLES OF INCORPORATION
OF
NATIONAL SALES ASSOCIATES OF FLORIDA, INC.**

ARTICLE I. - NAME

The name of this Corporation is NATIONAL SALES ASSOCIATES OF FLORIDA,
INC.

ARTICLE II. - DURATION

This Corporation shall exist perpetually.






