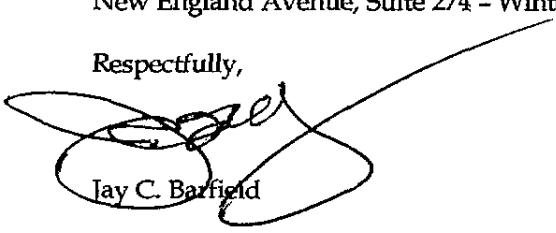

The undersigned Incorporators for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: FLORIDA HOME CONSTRUCTORS, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address is: 157 E. New England Avenue, Suite 274 - Winter Park, FL 32789

ARTICLE III - EXISTENCE

This corporation shall exist perpetually, unless dissolved according to law.

ARTICLE IV - NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida. While engaging in such activity or business, it may exercise all of the powers and privileges conferred by Chapter 607, Florida Statutes as presently in effect and as amended from time to time in the future.

ARTICLE V - SHARES

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is TEN THOUSAND SHARES of One Dollar Par Value Stock.

ARTICLE VI - INITIAL AGENT AND ADDRESS

The corporation shall have one director initially. The number of directors may be increased or diminished from time to time by the by-laws, but shall never be less than one. The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the Stockholders.

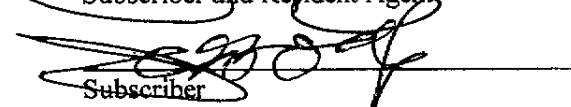
ARTICLE X - AMENDEMENTS

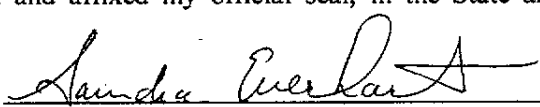
