

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned Sole Incorporator of Cutaneous Pathology Lab, Inc., a Florida corporation (the "Corporation"), hereby executes and submits for filing with the Florida Department of State these Articles of Amendment to the Articles of Incorporation of the Corporation to read as follows:

1. The name of the Corporation is Cutaneous Pathology Lab, Inc.
2. Article I of the Corporation's Articles of Incorporation is hereby amended to read as follows:  
  
"The name of the corporation is Physicians Pathology Laboratory, Inc."
3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
4. That no shares of the Corporation's capital stock have been issued.
5. Pursuant to Section 607.1005, this amendment to the Articles of Incorporation was adopted by the Sole Incorporator of the Corporation and shareholder action was not required.
6. This Amendment shall be effective upon its filing with the Florida Department of State.
