ARTICLE OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do herby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is ANIER #1 SURVEYING INC

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE
