ARTICLES OF INCORPORATION

OF

FURNITURE REPAIR AND ENHANGEMENT EXPERTS INC.

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articists of Incorporation:

ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is **FURNITURE REPAIR AND ENHANCEMENT EXPERTS**INC. hereinafter referred to as the "Corporation".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

as they may deem appropriate. The consideration may consist of any tangible or intangible property or benefit to the Corporation, including cash, promissory notes, services performed, promises to perform services evidenced by a written contract, or other securities of the Corporation.
