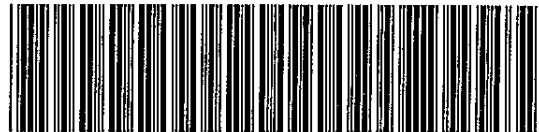

ARTICLES OF INCORPORATION

OF

ARTICLE ONE

The name of this corporation is JUS-DUE ENTERTAINMENT, INC. and the mailing address of the corporation shall be P.O. Box 62333, Fort Myers, FL 33906.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

ARTICLE THREE

The duration of the corporation is perpetual.

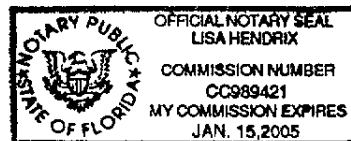

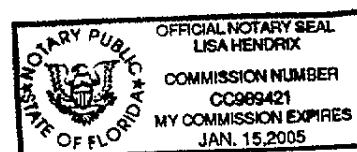

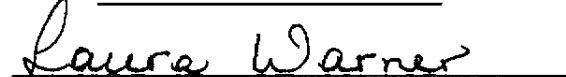
