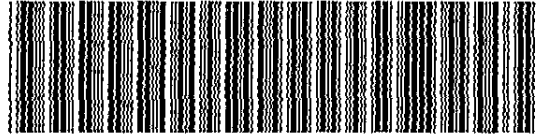



ARTICLE IV


The purpose or purposes for which the Corporation are to engage in any activity or


