NAME

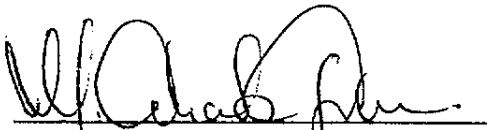

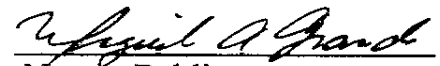

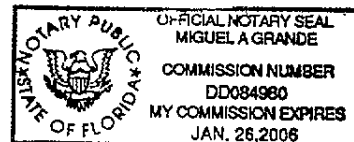
