

**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The corporation shall come into existence on August 8, 2003.

By-Laws




