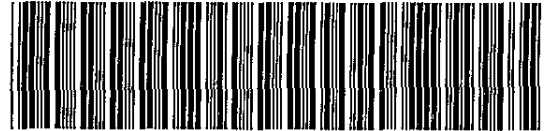



**CHARTER MILITARY SCHOOLS DEVELOPMENT CORPORATION**
