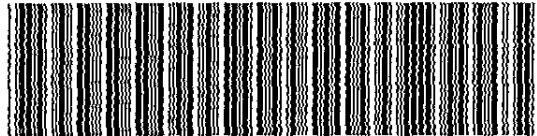

ARTICLE I: NAME OF CORPORATION

The name of the corporation is AC/DC ELECTRONICS INC.

ARTICLE II: MAILING ADDRESS OF THE CORPORATION
