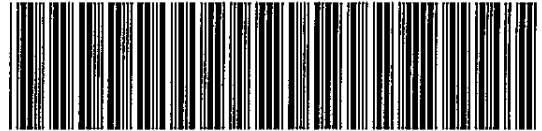

ARTICLES OF INCORPORATION  
OF  
PROVIDENTIAL HEALTH & REHAB, INC.

ARTICLE ONE

The name of the corporation is PROVIDENTIAL HEALTH & REHAB, INC.
