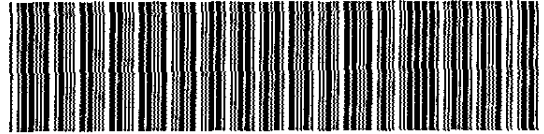

ARTICLES OF INCORPORATION
OF
JEFFREY A. POLAK, INC.

ARTICLE I

The name of the corporation is JEFFREY A. POLAK, INC.
