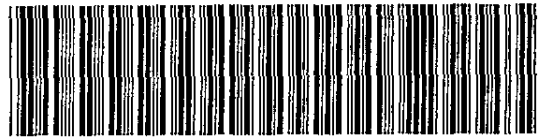

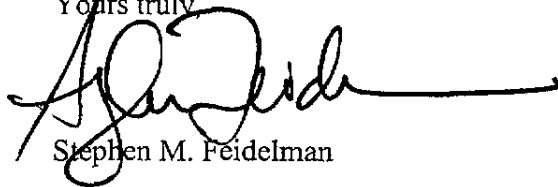

The name of this corporation is At Wireless Group, Inc.

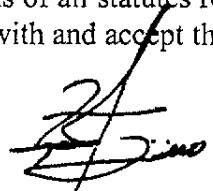
