ARTICLES OF INCORPORATION OF

ARTICLE L - NAME

The name of this corporation is Prowdy Services, Inc..

ARTICLE 2. - PRINCIPAL OFFICE: MAILING ADDRESS

The principal office of the corporation is initially 5824 Bee Ridge Road, #165, Sarasota, FL 34233 and the mailing address of the corporation is initially 5824 Bee Ridge Road, #165, Sarasota, FL. The corporation may change its principal office and/or mailing address from time to time as permitted by law.

ARTICLE 3. - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE 4. - CAPITAL STOCK

The corporation may purchase and maintain insurance on behalf of all officers and directors against any liability asserted against them or incurred by them in their capacity as officers and directors or arising out of their status as such.
