

# ARTICLES OF INCORPORATION for CK LAWN CARE, INC.

The undersigned, for the purpose of furning a corporation under the Florida General Corporation. Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I: NAME

The name of the Corporation is CK Lawn Care, Inc. Principal place of business is 3215 SW 61st Avenue, Davie, FL 33314.

#### ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.
