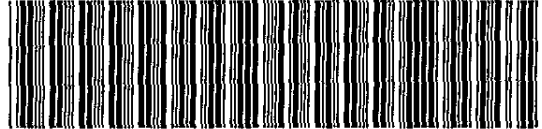

ARTICLES OF INCORPORATION

OF

LACEY'S PAST & PRESENTS, INC.

The undersigned subscriber of these Articles of Incorporation, the natural persons to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation shall be LACEY'S PAST & PRESENTS, INC.

ARTICLE II. ADDRESS

The mailing address of this corporation shall be 140 W. Plant Street, Winter Garden, FL 34787.

ARTICLE III. DURATION

This corporation shall exist perpetually or until such time as it may be dissolved in accordance with existing laws.

ARTICLE IV. PURPOSE

This corporation is to engage in all lawful businesses, including all powers necessary or convenient to effect its purposes as a unique collectibles, antiques, and gift shop.

ARTICLE V. CAPITAL STOCK


ARTICLE XI. INDEMNIFICATION


