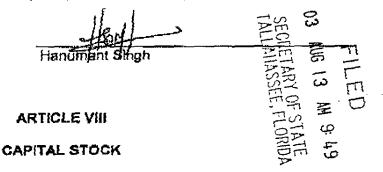
ARTICLE VII
