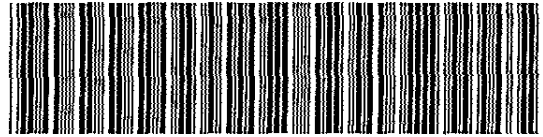



Articles of Incorporation  
of


