ARTICLE 1. NAME

THE NAME OF THIS SHALL BE AMERICAN LOCATORS SERVICE
CORP

ARTICLE 11. COMMENCEMENT & DURATION

THE COMMENCEMENT OF THIS CORPORATION'S EXISTENCE
SHALL BE AT THE TIME OF THE FILING OF THESE ARTICLES OF
