**ARTICLES OF INCORPORATION  
OF  
ITECH COMMUNICATIONS CORPORATION**

The undersigned, acting as incorporator of iTech Communications Corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation is iTech Communications Corporation

**ARTICLE II. ADDRESS**

The principal and mailing address of the corporation is Bob Crozer at 1 South Ocean Boulevard, Suite 210, Boca Raton, Florida 33432.

**ARTICLE III. COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence upon the filing of these Articles of Incorporation.

**ARTICLE IV. PURPOSE**

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

**ARTICLE V. AUTHORIZED SHARES**

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$0.01 per share.

**ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of the corporation is 1 South Ocean Boulevard, Suite 210, Boca Raton, Florida 33432, and the name of the corporation's initial registered agent at that address is Bob Crozer.

**ARTICLE VII. BOARD OF DIRECTORS**

The number of directors constituting the initial Board of Directors is one. The number of directors may be either increased or decreased from time to time, as provided in the bylaws, but shall never be less than one.

**ARTICLE VIII. INCORPORATOR**

The name and street address of the incorporator are Bob Crozer at 1 South Ocean Boulevard, Suite 210, Boca Raton, Florida 33432.

**ARTICLE IX. BYLAWS**

The power to adopt, alter, amend, or repeal bylaws shall be vested in the board of directors and the shareholders, except that the board of directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that the bylaw is not subject to amendment or repeal by the directors.

**ARTICLE X. AMENDMENTS**

The corporation reserves the right to amend, alter, change, or repeal any provision in these Articles of Incorporation in the manner prescribed by law, and all rights conferred on shareholders are subject to this reservation.


