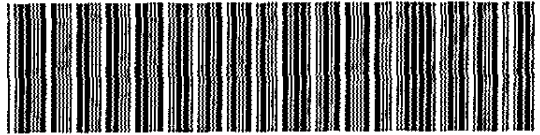

ARTICLE I. NAME

The name of the corporation is Braxton Solutions, Inc.
