**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is KITCHEN MAGICIANS OF CLEARWATER, INC. and the principal address and principal place of business is 1737 SHERWOOD STREET, CLEARWATER, FLORIDA 33755.

**ARTICLE II - REGISTERED OFFICE AND AGENT**
